

## Did you Know?

- 50-70% of women who are abused before pregnancy are abused during pregnancy.
- Women who are abused during pregnancy are more likely to delay entry into prenatal care.
- Women under 20 are most vulnerable to intimate partner homicide.
- 26% of teens who are pregnant report that they are physically abused by their boyfriends.
- 50% of pregnant teens who are abused said that the abuse started or intensified after the pregnancy was disclosed.
